

Invictus Companies LLC Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.invictusroofingandsolar.com, and Invictus Companies LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Invictus Companies LLC include www.invictusroofingandsolar.com, Invictus Companies, Invictus Roofing and Solar and www.invictusroofingandsolar.com, Invictus Roofing and Construction and www.invictusroofing.com, Invictus Solar Power and www.invictussolarpower.com. The Invictus Companies website is a construction services site. By using the Invictus Companies website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Sharing Information with Third Parties

Invictus Companies does not sell, rent or lease its customer lists to third parties.

Invictus Companies may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries.
